

I, ERNEST GRAFENBERG, residing in the City, County and State of New York, hereby declare and publish this as my Last Will and Testament, at the same time revoking all wills and codicils heretofore made by me.

FIRST: I give and bequeath:

(a) To DR. ZUELZER, now residing c/o Childrens' Hospital of the Medical School, Cincinnati, Ohio, if he shall survive me, my oil painting "Watzmann in Bavaria";

(b) To SIEGFRIED ARNDT, now residing at 45 Gateway Drive, Great Neck, Long Island, New York, if he shall survive me, my painting "Maerkische Landschaft";

(c) To MRS. MARIANNE ROSENBERG, now residing at Route 52, at Holmes, New York, if she shall survive me, the sum of Two Hundred (\$200.) Dollars in grateful memory of her late parents who contributed to efforts to liberate me from persecution by the Nazi regime.

(d) To DR. MAX JACOBSON, now residing at 155 East 72nd Street, New York, New York, if he shall survive me, the sum of Three Hundred (\$300.) Dollars;

(e) To my brother, HANS GRAFENBERG, now residing at Ostermalsgata 103, Stockholm, Sweden, if he shall survive me, the sum of Five Hundred (\$500.) Dollars;

(f) To MR. WALLACE R. DEUEL, now residing at 3026 Cambridge Place, Washington, D.C., if he shall survive me, the sum of Three Hundred (\$300.) Dollars;

(g) To TONI G. GOLDSMITH, now residing at 1193-14 Union Turnpike, Kew Gardens, Long Island, New York, if she shall survive me, the sum of Three Hundred (\$300.) Dollars;

(h) To MRS. LOTTE STERN, now residing at Tangiers, Morocco, if she shall survive me, or, if she shall not survive me, to her son, JOHN STERN, also residing at Tangiers, Morocco, if he shall survive me, the sum of Three Hundred (\$300.) Dollars;

(i) To MARGOT HOFFMAN, now residing at 3253 Cambridge Avenue, Riverdale, The Bronx, New York, if she shall survive me, the sum of Three Hundred (\$300.) Dollars.

SECOND: All the rest, residue and remainder of my estate, real and personal, wherever situated and whether acquired by me before or after the execution of this Will, including any property hereinbefore mentioned but not effectively disposed of, and including all property over which at the time of my death I shall have a power of appointment not otherwise exercised or released (hereinafter referred to as my residuary estate) shall be disposed of as follows:

1. To FRIEDEL G. HALSTEAD, now residing at 1547 Plunkett Street, Hollywood, Florida, if she shall survive me, ten (10%) per cent of my residuary estate.

2. To SUSAN F. GRAVEN, now residing at 19 East 86th Street, New York, New York, if she shall survive me, thirty (30%) per cent of my residuary estate.

3. To ANNEMARIE WIMBY, now residing at 248 East 68th Street, New York, New York, if she shall survive me, sixty (60%) per cent of my residuary estate.

In the event that any of the beneficiaries hereinbefore named in this Article "SECOND" of my Will shall have predeceased me, I direct that his or her portion shall

be divided equally among and added to the shares of such beneficiaries named in this Article "SECOND" of my Will as shall have survived me.

THIRD: In the event that any of the beneficiaries named in this my Will shall contest any of the provisions of this Will, I direct that the legacy, bequest or devise left to him or her herein shall be cancelled, so that such beneficiary shall not inherit any property under this Will, and I direct that in the event of such contest the share of my Estate which said beneficiary would have taken shall be added to and distributed as part of my residuary estate. In the event that such contesting beneficiary is one of the residuary legatees named herein, his or her share shall be divided equally among and added to the shares of such of the beneficiaries named in Article "SECOND" of this Will as shall have survived me.

FOURTH: I direct that all estate, transfer, succession, legacy, inheritance or other death taxes or duties, and any interest or penalties thereon, which shall become due and payable by reason of my death with respect to any and all property whatsoever passing under this Will, constituting my testamentary estate, included in my gross estate under the provisions of any tax law of the United States or any state thereof or any foreign country or subdivision thereof, shall be paid out of the principal of my said residuary estate, and that any and all such taxes, interest or penalties which shall become due and payable by reason of my death with respect to any and all property whatsoever passing outside of this Will, constituting my

non-testamentary estate, if any, included in my gross estate under the provisions of any such tax law shall be apportioned among the persons interested in such non-testamentary estate as provided under the laws of the State of New York existing at the time of the execution of this Will.

FIFTH: I appoint ERNEST HALSTEAD, of 90 Randolph Road, White Plains, New York, Executor of this my Last Will and Testament, and if he shall not survive me or for any reason shall fail to qualify as Executor, I appoint as my Executrix SUSAN F. GRAVEN. My Executor or Executrix shall post a bond as provided by law.

I direct that my Executor or Executrix shall receive compensation as such at such rates as are prescribed under the laws of the State of New York, provided, however, that such compensation shall in no event be less than three (3%) per cent of all sums of money received and paid out.
